ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely SAVITRAIBAI PHULE MAHILA VIKAS PRATISHTHAN, SAVKHEDE, POST PIMPRALA TAL & DIST-JALGOAN, MAHARASHTRA vide order No. WRC/5-6/106<sup>TH</sup>/2008/40400 dated: 28.08.2008 for conducting B.Ed.(M)CO-ED course with an annual intake of 100 students.

2. AND WHEREAS, the Revised Recognition order was issued to the institution vide dated 29.07.2015 for B.Ed. course with an annual intake of 100 students with a direction to not submit the compliance to the Revised Recognition order.

4. AND WHEREAS, the institution has submitted application for shifting of premises vide letter dated 18.11.2013.

5. AND WHEREAS, the matter was considered by the WRC in its 292<sup>nd</sup> meeting held on 15<sup>th</sup> -17<sup>th</sup> May 2018 and the Committee decided as under: -

*The case file was seen. VT visited the institution on 13/14.04.2018. The VT report was perused and the CD was viewed. The CD does not show the complete view of the building and the video graphing is faulty showing only part of the room, persons etc. The seminar hall is covered with asbestos sheets which is not permitted.*

*The new CD and/or pen drive should be submitted wherein all the requirements as per NCTE Regulations are available.*

*Hence, Show Cause Notice be issued on the above points, failing which recognition will be withdrawn. Reply should be submitted within two months.*

6. AND WHEREAS, a show cause notice was issue date the institution on 31.05.2018.the institution has submitted reply of show cause notice date. 03.04.2019.

7. AND WHEREAS, the reply to Show Cause Notice considered by the WRC in its 317<sup>th</sup> meeting held on 28<sup>th</sup> and 30<sup>th</sup> September, 2020 and the committee decided under:-

*The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. No. 5667/2020 and also the reply submitted by the institution dated 03.04.2019 to NCTE alongwith the original file of the institution was examined and Committee observed the following .-*

- The land documents submitted by the institution are for Plot No. 269/1, whereas all the other documents viz. CLU, NEC, Building Plan etc have been issued for 268/1.
- The Land Possession Certificate has been issued by the Advocate, whereas it should be issued by the Revenue Authority.
- The Building Safety Certificate has been issued by Architect, whereas it should be issued by the authority who has approved the building plan.
- The Building plan and BCC have been issued by the Sarpanch whereas as per the order dated 04.01.2013 issued by Tehsildar, clause 21 says "the permitted person should construct the construction as per the sanctioned map by Town Planning, Nanded". The WRC may please see.
- Total land area not mentioned in the Building Completion Certificate.
- The Non Encumbrance Certificate has been issued by an Advocate, whereas it should be issued by the Revenue Authority.
- As per VTR, the institution is having only 1664 books and 331 titles, whereas as per NCTE Regulations, a minimum of 3000 books and 1000 titles are required for initial recognition, with addition of 200 titles annually including books and journals.
- As per VTR, the salaries for the staff are being paid in cash, whereas it should be through account payee cheque / bank transfer.
- Additional FDR for Rs. 4.00 lacs not submitted.
- The staff appointed is not approved by the affiliating body.

*In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act.*

8. AND WHEREAS, a show cause notice was issue date the institution on 19.10.2020 and the institution has submitted reply of show cause notice date. 15.12.2020.

8. **AND WHEREAS**, the reply to Show Cause Notice was considered by WRC in its 324<sup>th</sup> meeting held on 23<sup>rd</sup> -24<sup>th</sup> and 31<sup>st</sup> December 2020 and the committee decided as under: -

*The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:*

*The institution has fulfilled all the requirements as per NCTE regulations 2014 and amended Regulations 2017.*


***In view of above, the Committee decided as under:***

***Shifting of premises of the institution allowed as per following address:***

***Old Address-*** Savitribai Phule Mahila Vikas Pratisthan, Savkheda, Post- Pimraha, Distt- Jalgaon, Maharashtra.

***New Address-*** Savitribai Phule Mahila Vikas Pratisthan, 269/1 Kandhar, Post- Distt- Nanded, Maharashtra.

9. **NOW THEREFORE**, as per the decision of WRC, shifting premises to **Savitribai Phule Mahila Vikas Pratisthan, Savkheda, Post- Pimraha, Distt- Jalgaon, Maharashtra** to new address for **Savitribai Phule Mahila Vikas Pratisthan, 269/1 Kandhar, Post- Distt- Nanded, Maharashtra** is permitted
